Parents are offered parent engagement workshops on a variety of topics including support for preparing for college, why CAASPP is important and how to support students, and Saturday math workshops for whole families.

In addition, all students are provided a laptop MacAir and parents are encouraged to use the device to help their student and check grades. Families are also provided internet.

With the assistance of Title I, Part 1 parents, the school educates staff members in the value of parent contributions, and in how to work with parents as equal partners (ESSA Section 1116 [e][3]).
